Mumzone Products Limited operated originally as the South Australian Fruitgrowers Co-operative Society Limited from premises in Payneham Road, St. Peters. The company was a food processing and distributing concern and specialized in jams and canned fruits.

In 1951 the company amalgamated with its competitors, J. Brooker and Sons Ltd, and the activities of both companies were carried on by a new company, Brooker (Australia) Limited <sup>(1)</sup>.

In June 1952, the St. Peters property was sold to the Department of the Army and the companies operations were removed to Glenroy Street, Woodville North <sup>(2)</sup>.

In November, 1962, an agreement was tabled for the sale of the whole of the assets of Mumzone Products Limited, J. Brooker & Sons Limited and Brookers (Aust.) Limited to Foster Clark (S.A.) Limited <sup>(3)</sup>, and in January 1963, a Receiver and Manager was appointed by the State Bank of S.A. to control the affairs of the latter company <sup>(4)</sup>.

The original St. Peters property of Mumzone Products Limited now houses the Jam Factory craft gallery and workshop. (1983).

These records were donated to the Archives by Mr. R. Allan, whose father, Mr. J.F. Allan, was Secretary of Brookers (Aust.) Ltd.
