

MILLER ANDERSON LIMITED

The beginning of Miller Anderson Limited can be traced back almost to the foundation of the colony of South Australia.

James Miller Anderson arrived in 1849 from London and joined his uncle Robert Miller, a partner in the drapery firm of Miller and Gale of 52 Hindley Street, Adelaide, which was established in 1840. In 1859, after various partnerships the business became J. Miller Anderson and Company and developed into a leading drapers, importers, tailors and home-wares emporium in this state.

In 1915 the firm was floated as a limited liability company under the name of Miller Anderson Limited. During the 1920's extensive additions were made to its premises with the erection of a five-storey building at 16-26 Hindley Street. The business became a public company in 1927 and was immediately taken over by Marcus Clark and Co. Limited of Sydney. Since 1966 the ownership of Miller Anderson has changed several times due to company takeovers by corporate names such as Waltons, Colonial Mutual Life and the Emanuel Group of Companies.

Miller Anderson Limited, beside operations at its Hindley Street Store, had also acquired several suburban shops and country branches at Clare and Naracoorte. In 1987 Waltons-Bond Limited sold the entire Miller Anderson company to the Venture Stores Group, who moved the premises to the Station Arcade further down Hindley Street a year later. After seven months of business there, Miller Anderson passed into receivership in October 1988, ending a distinguished trading history spanning 148 years as the oldest department store in South Australia.

The records of Miller Anderson Limited were donated to the Mortlock Library by Mr Noel Hunt, Managing Director in 1988.
