Particulars and conditions of sale of land in Kooringa and Graham, dated July 1913.

Note re particulars and conditions:

Particulars are lists of number of lot, allotment, area in measurement and nature of tenancy.

Conditions of sale are rules that must be abided by when selling land. Also includes contract.
