

**Records of United Aborigines Mission (UAM) - copies of records from the
UAM Archive made by Alison Longworth**

Special list**

The purpose of this special list is to cross-reference the original UAM Archive file number (including box number, file number and category number provided by the donor) and the current archival number. It reflects the structure of the collection PRG 1838.

The titles of each series and subseries are transcribed from the original UAM Archive title, Which is provided in PRG 1838/1/1 and PRG 1838/1/2, except for PRG 1838 Series 15 and 16.
