Francis Clark (1799-1853) and his wife Caroline (1800-77) emigrated to South Australia on the Fatima with their children Caroline Emily (1825-1911), Algernon Sidney (1826-1908), John Howard (1830-78), Henry Septimus (1837-64), Ellen Rosa (1838-99), Matthew Symonds (1839-1920) and Susan Mary (1846-1932) arriving at Port Adelaide on 11 June 1850. Soon after the arrival of the family in South Australia, Francis Clark established the firm of Francis Clark and Son, accountants and merchants. (1)

John Howard Clark, who joined his father's firm after an unsuccessful attempt to operate as an assayer, was active in the formation of the Adelaide Philosophical Society, and subsequently in the establishment of the South Australian Institute. He was also a proprietor of the Register from 1865, and its editor from 1870 until his death on 21 May 1878. (2)

Caroline Emily Clark in 1866 initiated the boarding-out of children (formerly maintained in the Destitute Asylum) on the system used in Edinburgh. Following a trial of the practice in 1866, the boarding-out system was begun on a large scale in 1872, under statutory authority given by the Destitute Persons Relief and Industrial and Reformatory Schools Act, 1872. Both Caroline Emily and John Howard Clark were members of the Boarding Out Society formed to supervise the children boarded out. In 1886 the Society was reformed as the State Children's Council, of which Caroline Emily remained a member until 1905. (3)

The Clark family papers were received between 1921 and 1991 mainly from descendants of Francis and Caroline Clark, including Mrs Joseph Crompton (senior), the Misses Crompton, E.V. Clark, Mrs A.C. Hardy and Mr J.W. Crompton.

April – September 1851. 1 cm
Diary written by Frederick Hill (1803-1896) at Bruce Terrace,
Tottenham in the weeks leading up to the death of his father
Thomas Wright Hill, founder of the Hazelwood School. The diary
appears to have been owned by his sister Caroline Clark. Included
are obituaries of Thomas Hill and an insertion by one of the other
sons, Arthur. One of Frederick's entries reads 'He also asked me
to tell Caroline that her dear image had been before him to the last'.

Poetry of C.E.C. <u>25</u> 1887-1892. 0.5 cm

Printed poems written by Caroline Emily Clark along with two envelopes, one with a handwritten entry 'Pattie with best wishes.' Poems include 'The Two Captains', 'Story of a Dewdrop', 'An Australian Song', 'An Australian Christmas Dream' and 'To the Women Voters Of South Australia [By One Of Themselves]. C.E.C.'s poetry was published in various South Australian newspapers including 'Register', 'Adelaide Observer' and Evening Journal. Many of the poems have annotations written for Pattie Crompton. Also includes newspaper cutting of the poem 'Lucy Ayers A True Story'.

Poetry album <u>26</u> 1827-1940. 3 cm

[Bound volume of poetry with poems by SSH who was probably Sarah Hill including 'To Caroline' which begins 'My sister...' and 'To my brother Howard'. There are also entries by T.W. Hill and C.E. Clark including 'To the Inventor of the Anemometer' about Uncle Osler and by Mrs Leonard Simpson of Charleston to S.M. Crompton on her 85<sup>th</sup> birthday, Feb. 28<sup>th</sup> 1931. Also includes a postcard to Lucy Crompton and a newspaper cutting of the text of the King's message.]
