

SNOSWELL, John and descendants

John Snoswell (1818-1873) of Deal, Kent, was engaged by the South Australian Company as an assistant boat builder and emigrated to South Australia aboard the <u>Africaine</u>, arriving at Kangaroo Island on 4 November 1836, later setting up in business as a boat-builder on his own account at Port Adelaide. He married at Holy Trinity Church in 1843 Elizabeth Holman (1821-1856) and on her death was remarried, also at Holy Trinity, to Eliza Curry who died in 1874. At the time of his own death in 1873 John Snoswell was proprietor of the Duke of Wellington Hotel at Port Adelaide.¹

John Mourilyan Snoswell (1844-1927), first son of John Snoswell and Elizabeth Holman, established himself as a saddle and harness maker in Grenfell Street. In 1873 he married Matilda Coleman who died in 1943, and around 1875 took up farming at Curramulka, returning to Adelaide after selling his property in 1909. There he acquired various real estate property and spent his retiring years at the imposing residence 'Hofwyl', Waverly Ridge, Crafers, which he purchased in 1913 when sold at auction by C.A. Horn.²

Cleveland Frank Snoswell (1893-1980), third child of John Mourilyan Snoswell and Matilda Coleman, enlisted in the 50th Infantry Batallion as a private soldier in 1916, was wounded in action in 1918 and returned to Australia aboard the Khyber in 1919. In 1920 he married Gladys Emily Louise Westcombe (1893-1981). He derived his income from rental properties and their sale and also ran 'Windsor Farm' at Woodside.³

The papers comprising Private Record Group 912, covering three generations of the Snoswell family, were donated to the Mortlock Library by Mr Bronte Mourilyan Snoswell.
