

On July 11 1854 a group of people of the Unitarian Christian denomination met in Adelaide and resolved to found their own church and seek a suitable minister from England. The Rev. John Crawford Woods BA was selected and arrived on the *Quilto* from London on September 19 1855. Services were initially held by Mr Woods in private houses until October of that year, when the first public service was held near Green's Exchange in King William Street, Adelaide.

Land on city acre 302 in Wakefield Street was acquired on which to build a church, and the foundation stone laid on December 23 1856; the building was formally opened for public worship on July 5 1857. Later a Sunday School building was erected next to the church.

The Unitarian Church did not develop other branch congregations except for a small country following centred in the Shady Grove church at Harben Vale near Hahndorf, in the Adelaide Hills, which was built in 1865, and the Tranmere Church 1932-1956. The Unitarian following was therefore small compared with other denominations; in 1903, however, it is believed about 700 South Australians called themselves Unitarians.

The Wakefield Street church, one of Adelaide's most impressive religious buildings in its day, became dilapidated in the 1960s and a move was made to acquire more convenient premises elsewhere in the city. Eventually land was purchased on Osmond Terrace, Norwood and the Unitarian congregation sold their old church to the Public Service Association for \$87,000. The last service at Wakefield Street was held on February 14 1971.

New church premises, including an adjoining manse for the minister was designed by architect Eric von Schramek in 1970. The stained glass windows and the organ from the old church were incorporated into the interior decoration of the new building. The complex was officially opened on October 3 1971, the anniversary date of the first public Unitarian service in South Australia.

Records of the Adelaide Unitarian Christian Church were deposited in the South Australian Archives in 1972 and 1973 by the Treasurer Mr A.M. Simpson. The balance was deposited in the Mortlock Library in 1990 by the Minister Rev. E. Heller-Wagner
